#### **AFINANCIAL REPORT:**

• Finance Director, Grace Seeney indicates GHA is waiting on GASB68 numbers from FY2022 for the audit. GHA anticipates HOME support funding in the amount of about \$15K and about \$19.5K from a settlement agreement to be paid overtime. GHA is working on Tenant Accounts Recivables (TARS) past due rents and Finance Director, Grace Seeney indicates GHA is offering the RentPayment module to provide the residents an easier option to pay their rent. Overall, GHA is operating at a loss of \$27K. E.D. Gober highlights that a bulk of the net loss is due to the Williams Street property, which is more expensive than the other properties to maintain. E.D. Gober indicates the audit is due to HUD September 30, 2023, we anticipate it to be complete in August as the state released the GASB68 unfunded pension liability numbers in June, the appropriate figure needs to be recorded for GHA, which will be an audit adjustment.

## **DIRECTORS REPORT:**

- E.D. Gober indicates in respect to the electric matter at Delsea Manor, the switch plates were changed to return control of the porch light to the residents and informed that GHA was unable to calculate the amount to be credited to the residents until this was complete. The time period of the electric credit starts in February of 2021 and ends in July of 2023, GHA is calculating using whole months. Once calculations are made GHA will credit the rental account of the residents, GHA's methodology will be communicated with the residents.
- E.D. Gober indicates the House released the funding appropriations bill, the voucher program, where the funds to operate the GHA RAD units comes from, has a proposed 4% increase. The voucher program administrative funding, that GHA receives to administer the program, proposed a 1% decrease. Some programs have severe cuts such as Choice Neighborhoods which is wiped out entirely and the HOME program has a 67% cut, these don't affect the actual

operations at GHA, but they do affect our community. The County receives CDBG and HOME funding.

- E.D. Gober indicates on July 14, 2023 a notice was published for the Village at Harmony Garden, the waitlist will be closed effective August 1, 2023 for all categories other than special needs. There are sufficient applicants for all categories, but special needs and we do not want to keep the waitlist open and create a false sense of hope to the community.
- E.D. Gober indicates that Pennrose is working on submitting information to Gloucester County for HOME funds, the project did receive a grant for HOME funds, next Pennrose will be submitting close-out documentation to be followed by a submission to HUD for a final closeout to then close-out the construction loan moving the project to permanent financing, which is anticipated to happen by fall.
- E.D. Gober indicates there was need for an emergency contract for the replacement of a circulator pump, three pressure control valves and flooring at a Whitney Gardens unit.
- E.D. Gober indicates there are three procurement related resolutions on the agenda, RES# 2023-45 authorizing GHA to perform competitive contracting in soliciting RFP's, RES# 2023-46 authorizing a general delegation of power to negotiate and award contracts pursuant to N.J.S.A. 40A:11-3 and RES# 2023-47 authorizing the award of contracts that are in the aggregate less than 15 percent of the bid threshold without soliciting competitive quotations pursuant to N.J.S.A. 40A:11-6.1(c). D.E.D. Jeffrey Daniels, Esq. discusses the procurement-related resolutions with the Board.
- E.D. Gober indicates RES# 2023-43 asks for the Boards approval regarding the submission of an application for the HOME Support Program advertised by Gloucester County Division of Senior Services, the application is due August 10, 2023. This grant provides the HOME Support services to GHA residents assisting with paying the salary of the staff that provides the services to the residents.
- E.D. Gober indicates GHA is a member of the New Jersey public Housing Authority Joint Insurance Fund (NJPHA JIF), the NJPHA JIF is requiring appraisals by September 1, 2023, this is upcoming and a result of the significant changes in the market. NJPHA JIF will be onsite August 19, 2023 to complete loss control and right to know inspections.
- E.D. Gober inquires if the Board would like to move the location of the Board meetings to the Williams & Grillo Street facility to allow equal opportunity for public participation as practiced in the past, the Board would like to change locations for the October meeting.

 Vice-Chairman Edward Hutchinson inquires if GHA has sent out any letter to our residents regarding the excessive heat, E.D. Gober advises that GHA has published such in the newsletters and communicates opportunities to residents such as when Gloucester County distributes fans, etc., E.D. Gober advises a message can be inserted in the upcoming newsletter.

- E.D. Gober indicates the packets contain an article by Thriven Design mentioning Village at Harmony Garden (VHG) regarding changes in affordable housing and the supportive housing component of VHG.
- E.D. Gober advises the packets contain an article regarding the Camden Housing Authority, the HUD Office of Inspector General had performed an investigation discovering fraud by the Director of the Housing Choice Voucher Program by way of funneling funds to properties that the individual had an ownership interest in, which is prohibited. E.D. Gober notes the internal controls GHA has put in place to prevent this, GHA checks ownership on tax records and also has owners provide proof of ownership such as a deed, if the entity is an LLC, GHA requests the forming documents of the entity to identify who has interest in that entity.
- E.D. Gober highlights the need for affordable housing continues, GHA has voucher holders who
  continue to have difficulty finding units with third party landlords that meet the affordability
  requirements of the voucher. Glassboro has always had a challenging housing market due to
  the university. GHA has increased the payment standard to 120% of HUD's established SAFMR.
