• Patricia Grandi of 176 Delsea Manor presents the Board with the following comments/concerns:

- o Clearing of surrounding businesses sidewalk access ramps during winter.
  - E.D. Gober recognizes the concern GHA residents have regarding snow removal from surrounding private properties such as Shoprite and Commissioner Andrew Halter indicates that the Borough of Glassboro would happily reach out to the landlord of Shoprite regarding the snow removal.
- Louise Nemeth of 176 Delsea Manor presents the Board with the following comments/concerns:
  - Status of her apartment's screen door, advises GHA staff was out earlier in the week to check on the door.
    - E.D. Gober indicates that if there is a work order submitted and staff has come out to the unit, the issues are currently being addressed. Site Manager Madeline Vazquez indicates that a work order has been submitted. E.D. Gober reminds that any issues needing attention, whether in a resident's unit or not, the proper channel to communicate with GHA is to call the work order number so that a work order can be entered and may be tracked to completion.

### **AFINANCIAL REPORT:**

- Grace Turchi, Finance Director, indicates RES# 2023-69 deals with designating uncollectible rents, the balances have previously been expensed through the allowance for doubtful accounts.
- Grace Turchi, Finance Director indicates that GHA is operating at a loss of about \$26K, mostly attributed to Williams and Grillo, the admin fee from Village at Harmony Garden PBV units is expected to decrease the loss. Net loss before depreciation is about \$83K and when depreciation is added back is calculated to \$26K of operating loss. E.D. Gober indicates as discussed previously many Housing Authorities across the nation have seen an increase in Tenant Accounts Receivables and advises the Commissioners that GHA charges an affordable rent, generally 30% of the residents monthly adjusted income. GHA will offer repayment agreements and is pursuing eviction for nonpayment of rent if there is no other option.
- Commissioner Andrew Halter inquires about current occupancy at GHA. E.D. Gober discusses vacant units needing updates and difficulty leasing units.

# **DIRECTORS REPORT:**

• E.D Gober indicates the Federal Government passed a continuing resolution, the T-HUD portion of the bill has two expiration dates, first expiration is January 19, 2024 and then there's this

- second expiration date of February 2, 2024 for commerce, justice, science, defense and financial, additional details are contained in the article included in the board packet.
- E.D. Gober indicates the agenda includes RES# 23-113, 23-114, and 23-115 regarding the RFPs for professional services. Brown & Connery LLP are recommended for primary legal counsel FY24, Angelini, Viniar and Freedman, LLP for secondary legal counsel FY24. For audit services FY23 Bowman & Company LLP is recommended and for consulting services FY24 The Brooke Group is recommended. E.D. Gober indicates the agenda also contains multiple resolutions regarding emergencies including floor replacements and roofing repairs, all work has been completed and is now brought back to the Board from a regulatory perspective deeming the emergencies. RES# 2023-68 asks the Board to authorize a contract for floor covering services RFP 23-001 that would allow an unlimited quantities contract for flooring. RES# 2023-74 recommends that the Board rejects the bids for Turnover Maintenance Work IFB 23-002 due to a deficiency in paperwork required by law.
- E.D. Gober indicates that HUD is implementing a new inspection protocol called NSPIRE. NSPIRE is a mandatory inspection protocol for public housing. For properties inspected under the voucher protocol, which is Housing Quality Standards (HQS), the implementation can be deferred for one year. GHA has chosen to defer NSPIRE protocol for one year since the contractual relationship with third party landlords has not yet been established by HUD. At this time GHA will be required to inspect under NSPIRE effective 10/1/2024. The new NSPIRE protocol will make it more difficult for landlords who have older housing stock to comply.
- E.D. Gober advises the Board of GHA's Thanksgiving and Christmas luncheons.
