- E.D. Gober generically indicates that whether an animal is a pet or an assistance animal the animal
  is expected to comply with the lease, meaning to not present a safety hazard, GHA will follow the
  lease.
- Commissioner Andrew Halter indicates he has spoken to the police chief regarding the noise complaints previously raised by residents of Delsea Manor and was advised that the police have increased patrols in the area. E.D. Gober indicates correspondence was shared with the residents regarding the matter, adding that residents that feel unsafe should contact the police.

## **AFINANCIAL REPORT:**

report has been released, the auditors have advised there is a missing component that is needed
to complete the audits. Audits are due to HUD by September 30, 2025.

# **DIRECTORS REPORT:**

 E.D. Gober indicates as previously discussed that HUD notified GHA that the Tenant Based Rental Assistance Housing Choice Voucher (HCV) Program is in shortfall. This means the funding allocation received for the year, notification of funding was received in May 2025, and the housing authority's HUD held reserves are not sufficient to pay the Housing Assistance Payments (HAP) for the units currently under lease through the end of 2025. GHA has applied for shortfall funding and in doing so GHA has certain obligations to fulfill such as not issuing any new vouchers in order to use available funds on current leases and avoid terminating families from the program.

- E.D. Gober indicates the one big beautiful bill was signed into law recently, it did include an
  expansion on the low-income housing tax credit and the house appropriations subcommittee
  release their proposed spending bill, it proposes funding cuts on the HCV program and possibly
  eliminating funding for the home investment partnership program, although not a direct impact on
  GHA, it would impact the County who receives an allocation of HOME funds. E.D. Gober will advise
  as more information is available.
- E.D. Gober indicates there is an article in the Board packets regarding the relocation of the HUD headquarters.
- E.D. Gober provides a brief summary of the agenda items, adding that last month the Board approved the replacement of the roof of the Williams Street building that was beyond its useful life, the work will start on 7/18/25.
- E.D. Gober indicates GHA continues conversations with the Borough regarding the possible redevelopment of the Williams and Grillo properties as well as the plot of land on Higgins Blvd. E.D. Gober recommends establishing a development committee.
