**RESOLUTION OF THE HOUSING AUTHORITY

EXTENDING EXTERMINATION SERVICES CONTRACT
FOR ONE YEAR PERIOD**

WHEREAS, the Housing Authority of the Borough of Glassboro recognizes the need to have extermination services; and

WHEREAS, the Housing Authority of the Borough of Glassboro awarded the bid for Extermination Services to E & G Exterminators, Inc. for a period commencing October 1, 2013 through September 30, 2014; and

WHEREAS, the contract allowed for a renewal option; and

WHEREAS, the Housing Authority of the Borough of Glassboro desires to extend the Extermination Services to E & G Exterminators, Inc. for an additional period commencing October 1, 2014 through September 30, 2015; and


WHEREAS, it is recommended the Board of Commissioners award a contract extension to E & G Exterminators, Inc. to provide the Housing Authority of the Borough of Glassboro with its extermination services for the period October 1, 2014 through September 30, 2015 an annual cost of \$1,428.00.


