
WHEREAS, prior to the Board meeting members of the Board of Commissioners read and reviewed the itemized list of incurred expenses attached hereto and does recommend payment;

2. The Courier Post, 301 Cuthbert Boulevard, Cherry Hill, NJ 08002


WHEREAS, a copy of this Resolution shall be published in the Gloucester County Times as required by law within ten days of its passage.
