WHEREAS, U.N.I.T. is a specialized program geared to teach law enforcement officers how to work in an undercover role; and

WHEREAS, U.N.I.T. is a professional narcotics training program attended by students who are professional law enforcement officers; and

NOW, THEREFORE IT BE RESOLVED, that the Commissioners of the Borough of Glassboro Housing Authority allow LAW ENFORCEMENT TRAINING in the 5 (five) Units at said property until property is demolished; and

BE IT FURTHER RESOLVED, that the U.N.I.T. may use this property at any time with the appropriate notice and insurance documents provided;


