**RESOLUTION AUTHORIZING A WAGE OFFER TO THE
COMMUNICATIONS WORKERS OF AMERICA LOCAL #1085 (“UNION”) TO
RESOLVE THE AGREEMENT BETWEEN**

**THE BOROUGH OF GLASSBORO HOUSING AUTHORITY AND
THE COMMUNICATIONS WORKERS OF AMERICA**

**FOR THE PERIOD OF
JANUARY 1, 2012 TO DECEMBER 31, 2017**

WHEREAS, the Borough of Glassboro Housing Authority (“GHA”) and Communications Workers of America (“Union”) entered into a labor agreement for the period of JANUARY 1, 2012 TO DECEMBER 31, 2017. It is attached as “Exhibit A”,
and;

WHEREAS, GHA and the Union, through their respective representatives, have met on multiple occasions to negotiate wages pursuant to the Agreement; and;

WHEREAS, the Borough of Glassboro Housing Authority Board of Commissioners desire to resolve the JANUARY 1, 2012 TO DECEMBER 31, 2017 Labor Contract Agreement by offering a 0%, 0%, 1%, 2%, 1.5% AND 1% from 2012 thru 2017 , respectively to current employees who were employed during that time, and;

WHEREAS, the Borough of Glassboro Housing Authority through its legal representative be and hereby is authorized to execute the aforementioned salary increases of 1% and 2% which shall be retroactive to January 1, 2014 and January 1, 2015 respectively, for eligible employees, and;

IT IS FURTHER RESOLVED, that beginning January 1, 2016, longevity will be folded into base pay on a one-time basis, with longevity no longer being paid by the GHA, and;

BE IT FURTHER RESOLVED by the Chairman and Executive Director of the Borough of Glassboro Housing Authority, that the Labor Contract Agreement between the Borough of Glassboro Housing Authority and CWA for JANUARY 1, 2012 TO DECEMBER 31, 2017 hereby is approved and settled, and;

ADOPTED at a Regular Meeting of the Borough of Glassboro Housing Authority on the 20th day of July, 2015.
