WHEREAS, prior to the Board meeting members of the Board of Commissioners read and reviewed the itemized list of incurred expenses attached hereto and does recommend payment;



RESOLUTION AUTHORIZING THE TRANSFER OF OFFICE FURNITURE AND RELATED ITEMS TO THE BOROUGH OF GLASSBORO IN EXCHANGE FOR UTILITY CONNECTION SERVICES AT ELLIS MANOR FACILITIES

WHEREAS, the Housing Authority of the Borough of Glassboro (GHA) presently owns office furniture and related items, which have no immediately identifiable use with regard to the GHA's daily operations;

WHEREAS, the GHA is in need of certain utility connection services at its Ellis Manor facilities, which are to be performed by the Borough of Glassboro;

WHEREAS, the GHA and the Borough of Glassboro have discussed a cost neutral exchange involving the GHA's transfer of the aforesaid office furniture and related items in exchange for the Borough of Glassboro's provision of utility connection services at the Ellis Manor facilities; and

WHEREAS, the GHA has determined that the transfer of office furniture to the Borough of Glassboro in exchange for the aforesaid utility connection services is a cost-effective and efficient manner of accomplishing a vital operational need.

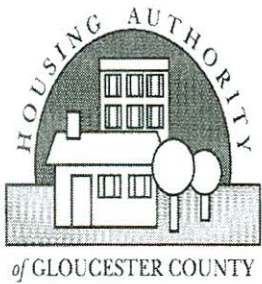
