GHA shall only receive proposals electronically via Housing Agency Marketplace until **June 30, 2026 at 11:00 am EDT** in response to this Request for Proposal 26-001 (RFP).

Proposals shall be submitted in the manner specified herein and as required by the RFP specifications via Housing Agency Marketplace. Vendors must register as a vendor with Housing Agency Marketplace to submit an electronic proposal. GHA reserves the right to reject all proposals received by reason of this RFP. Vendors whose proposals are not selected will be notified electronically in writing. GHA is soliciting proposals through a fair and open process in accordance with *N.J.S.A. 40A:11-1 et seq.* and federal procurement laws. GHA reserves the right to waive informalities in proposals.

Proposals shall comply with all applicable federal, state, and local statutes, rules, and regulations. The selected vendor shall comply with P.L. 1975 c.127, *N.J.S.A. 52:32-44*, *N.J.S.A. 10:5-31 et seq.*, *N.J.A.C. 17:27 et seq.*, and applicable federal law.

Questions concerning this RFP shall only be accepted through Housing Agency Marketplace. GHA shall answer all questions by issuing an addendum to the RFP through Housing Agency Marketplace. It is the obligation of the vendor to determine if any addenda were issued by GHA. Failure to acknowledge receipt of addenda shall result in a proposal being rejected. Please note that any attempts to deliver a proposal other than electronically via Housing Agency Marketplace shall be rejected.
